PART III: DECLARATION OF NOMINEE

I solemnly declare that:

1. I am a Nisga'a citizen and am 18 years of age or older;
2. I am qualified to be a candidate for the above-named elected office. I have reviewed section 15 of the *Nisga'a Elections Act* and section 12 of the *Nisga'a Elections Regulation*, attached to this Acceptance Form. I am not disqualified from being a candidate for any reason set out in section 15(2) of the *Nisga'a Elections Act*;
3. the information set out in this Acceptance Form is complete and accurate; and
4. if I have in Part I of this Acceptance Form specified a usual name (different from my full name) that I wish to be used on the election ballot, the specified name is my usual name.

I hereby authorize the Nisga'a Elections Officer to conduct any investigation that the Nisga'a Elections Officer considers necessary to verify any information set out on this Acceptance Form or to otherwise confirm my qualification as a candidate for the above-named elected office.

PART IV: NOMINEE CERTIFICATION FROM CHIEF FINANCIAL OFFICER

- I enclose with this Acceptance Form written certification from the Nisga'a Lisims Government's Chief Financial Officer that my name was not included on the register of prescribed debts as of the date of the nomination meeting at which I was nominated.
